GUIDELINES FOR PAPER SUBMISSION

- 1. Abstract should describe the broad content of the paper and should not be more than 300 words. Research background, Aims, Methodology, Results/Findings, and Implications are essential elements of the abstract.
- The length of the paper should not exceed 6000 words. The paper should contain the Title of the paper, Author's name and details, Introduction of the topic, Need of the study, Objectives, Hypothesis, Research methodology, Data collection & Analysis, Testing of Hypothesis, findings & Interpretations, Implications, Conclusions, Suggestions and References.
- 3. The author(s) name must not be mentioned anywhere except on the cover page of the research paper.
- 4. Papers should be typed in MS-WORD with single spacing on A4 size page in Times New Roman style with font size 12 and 1 inch margin on all four sides with APA referencing for all citations.
- 5. A soft copy of the abstract should be submitted as an e-mail attachment to pathh@sfimar.org on or before 26th April 2024. For the full paper, one soft copy should be submitted to the same email id on or before 25th May 2024.
- Each paper will undergo Plagiarism check and a Similarity Index of less than 10% only will be accepted for a desk review followed by a double-blind review.

EVALUATION CRITERIA FOR SELECTING PAPER

- > Relevance: Research paper that broadly cover the conference theme/Subtheme.
- Methodology: Use of sound and appropriate methods to support the objectives & test the hypothesis / or theory driven empirical findings and discussion.
- Originality: Paper that bring forth new ideas and insights, create new body of knowledge / Theory / Concept / Model etc.
- > Conclusions: Sound conclusions and justification.
- > Implications: Relevance and implications of the decision problems demonstrated.
- > References: Acknowledgment of works of others referred in the paper in the APA format.



The submitted papers will be double blind reviewed by the screening committee and the accepted papers will be selected for presenting in the conference. The authors of the accepted papers will be intimated as per the scheduled date put up below.

PROCEEDINGS OF PATHH 2024

The authors of accepted papers will be awarded Certificates. Selected papers will be published in Web of Science / UGC CARE Listed Journal (Publication charges as applicable will be additional). Opportunity to get select papers published in the regular issue of the Journal 'Management and Labour Studies (MLS)' of XLRI, Jamshedpur, which is an Australian Business Deans Council (ABDC) / SCOPUS Listed Journal (Publication charges as applicable will be additional). Remaining papers will be published in SFIMAR Research Review (Print ISSN: 0975-895X and ISSN Online: 2581-7450).
